1. Opening of Meeting - Amanda Martinez, Assistant Superintendent, Pupil Services

3. Transportation – Ben Hazen, Transportation Supervisor, Shawn Dahlen, Director of MOT and Amanda Martinez, Assistant Superintendent of Pupil Services

The committee split up into 3 groups and toured the school.

6. Representative Discussion/Announcements/Reports

Celeste Kafri asked to see the LCAP notes that were taken during the DAC/DELAC meeting on February 15th. She also stated that she has been reading about how the most effective teams are structured and requested that the committee talk about how they can use these ideas to make DAC as impactful as possible. She would like the parents on the DAC committee to have more say in the topics presented at the DAC committees.

Ms. Martinez and Mrs. Rockwood explained that topics are chosen months prior to the start of the new school year and that there are certain topics that must be covered. Annually, at the DAC meeting in May, the

Superintendent gives the committee an opportunity to give input on which topics they would like to have on the

agenda for the following year. If the Superintendent feels that those topics are relevant, they may be put on the

agenda.

Lisa Caffery asked what the purpose of the DAC meeting was?

Ms. Martinez and Mrs. Rockwood explained that this information can be found in the DAC Bylaws, but also went

on to explain that this committee is not only for parents to learn about each of the schools and processes of the

district that they can bring back to their PTAs, SSCs or parent groups, but it also provides a forum for parents to

discuss areas of concern, importance or celebrations with the Superintendent.

Greta Bruneel stated that parents at La Patera school were unhappy that the DESSA Mini results were sent

home with students in unsealed envelopes and that parents would like more context on the DESSA Mini.

Ms. Martinez explained that a ParentSquare was sent to all parents, explaining the process which gave complete

information about the DESSA Mini. Mrs. Bruneel, along with a few other committee members, acknowledged

that they do not read all of the ParentSquare messages so they could have missed that particular notification.

Stacy Demmin has a child who was in the red on the DESSA Mini, was not offered follow-up and had to ask for

follow-up. She would like to know what parents are supposed to do with the information? She suggested that

this information be shared with them during parent/teacher conferences.

Ms. Martinez made a note of this and said that she would speak with Leadership about the way that the results

are distributed to parents.

PARKING LOT QUESTIONS AND ANSWERS:

Q: Many school Boards around the country post meetings on YouTube, including SBUSD. Can we start doing this at

GUSD so DAC/parents are better informed?

A: The video option was considered and it was determined that the audio version hybrid was the most cost effective

approach while still providing access to all of the Board presentations and information to the public.

Q: Can we find out the total transportation cost, including staff?

A: As of 3.29.24 we have spent \$1,104,497 on transportation and are budgeted to spend \$1,570,988.

Q: Can we find the number of pupils served? 554 Eligible Students?

A: • 298 General Ed Riders

- 40 Special Ed Riders
- 67 After School Program Riders

Q: If we can't send a bus to pick kids up, what is the alternative?

A: We are obligated to provide transportation to Special Education Students per Educational Code. We are also obligated to provide transportation to students in the afterschool program per State ASES requirements for students from low-income families. Our GUSD Board Policy requires transportation for families who live a distance of 2 or more miles from their neighborhood school. If we do not provide transportation, our attendance rates would probably decline substantially as some families do not have transportation. Public transportation may be an option for some families, but we have very young children and public transportation or walking 2+ miles would not be a viable option.
